The publication takes place within the first six months of the following year. The information remains in the public domain for a period of at least three years from the time of publication. Medical Concept Lab S.r.l., also keeps the documentation supporting the published data in electronic format for a period of at least five years and also makes it available in detailed form to any request from the Professional / Healthcare Organization / Third Party. The data concerning transfers of value are published in the State where the beneficiary has his domicile and the obligation of publication in the case of corporate groups is also intended to be extended to the parent companies of the associated companies, and / or to other companies belonging to the group, in compliance with the relevant national codes or regulations. VAT and other taxes: Transfers of Value are published in Euros net of VAT and other local taxes.
